# Violation of City Ordinances - Parking

As many of you know, Lago Vista is growing, growing....**growing!**

With this growth comes more vehicular traffic and places to store those motor vehicles. The Lago Vista Police Department works in conjunction with the City of Lago Vista Code Enforcement Division on a regular basis. Recently, the Police Department and the Code Enforcement have noticed an increase of habitual parking violations within the city limits of Lago Vista.

Many times, when an Officer sees a violation, they will place a red warning sticker on the window of the vehicle. This sticker is just a warning and does not require any follow up, except to fix the violation listed on it.

Once a sticker has been issued, an Officer will follow up to see if the violation has been fixed, and if it had not, a citation typically follows. We at the LVPD do not want to just hand out citations. We want to gain compliance by first issuing a warning and then following up if further action needs to take place.

We encourage everyone to read up on the parking statutes and try their best to adhere to them. Typically, on holiday weekend/events, we see such an increase in the parking violations that we tend to document them mentally and then once the weekend is over, take further actions. ## 6.65 Storage and Parking of All Vehicles, Including Boats, Trailers, and Recreational Vehicles.

(A) Storage of junked or unlicensed vehicles, including recreational vehicles, boats and trailers, outside a building that completely screens it from view from any direction except from above, on any lot or parcel is prohibited. Covering the vehicle with any material is not screening.

(B)(1) All vehicles, including but not limited to recreational vehicles, boats, trailers, commercial vehicles and trailers, that are not involved in permitted or authorized construction or development activity parked in front of the building setback line or in front of the rear yard in the side setback shall be on a concrete or asphalt driveway or parking apron, or an improved surface capable of supporting the vehicle such as concrete, asphalt, pavers or similar material.

(B)(5) No vehicles shall be parked or stored in the front yard or corner side yard facing a street not an alley unless the vehicle is parked or stored on a driveway.

## Sec. 12.811 Overnight Parking

Overnight parking for storage on any paved street is hereby prohibited. "Overnight parking for storage" is hereby defined as the habitual parking or storing of cars, trucks, tractors or other vehicles on paved streets during the hours from sundown to sunup, except temporarily disabled vehicles which are protected by flares or other approved signal devices. It is not the intention of this section to prohibit or interfere with passenger cars temporarily parked at night, where such parking is not done regularly and during the entire night.

# PROPERTY CRIMES

## **Criminal Mischief— Paine Avenue**

Officers were dispatched to a call in which a complainant stated that his front door had been kicked in. It did not appear that anyone had made entry into the residence due to the complainants dogs inside. Further investigation led officers to find that the complainant had a warrant for his arrest. He was arrested for the warrant and the case is under investigation.

## **Burglary of a Motor Vehicle — American Drive (The Island)**

Officers were dispatched to a call in which a complainant stated that he had obtained video footage of multiple boat burglaries during the prior night. The case is under investigation.

## **(Multiple) Burglary of Motor Vehicles — Thunderbird/Bonanza**

Officers were dispatched to multiple calls in which a complainants stated that their vehicles had either been broken into or rummaged through. All the reported burglaries were on vehicles that had left their doors unlocked overnight. These cases are under investigation.

## **Criminal Mischief— American Drive (The Island)**

Officers were dispatched to a call in which a complainant stated that multiple subject had 'jumped' the fence into a private pool area. The subjects damaged signs and loitered for many hours. This case is under investigation.

# CRIMES AGAINST PERSONS

## **Assault Family Violence — Clubhouse Drive**

Officers were dispatched to a call in which the a mother and daughter were involved in a physical disturbance. Upon officer arrival, they had to separate the two parties. The investigation led officers to arrest the mother for assaulting the daughter.

# DRUGS / NARCOTICS / ALCOHOL

## **Possession of a Controlled Substance— Lohman Ford Road**

Officers on patrol conducted a traffic stop. Officers investigated, which resulted in the charge of possessing a controlled substance. The driver was arrested for the offense.

## **Possession of Drug Paraphernalia / Warrant — Pershing Avenue**

Officers on patrol conducted a traffic stop. Officers investigated, which resulted in the charge of possessing drug paraphernalia for the passenger. The driver was arrested for an active warrant out of Williamson County for a 'Parole Violation'.

## **Possession of Drug Paraphernalia — FM 1431**

Officers on patrol conducted a traffic stop. Officers investigated, which resulted in the charge of possessing drug paraphernalia for the driver. He was issued a citation and released.

## **Public Intoxication — La Mesa**

Officers were dispatched to a report of a wrecked vehicle. The vehicle was located with a male subject standing outside it. The male subject appeared intoxicated. The subject was cited for Public Intoxication and transported by EMS for evaluation.

## **Public Intoxication (x2) — Coyote Trail**

Officers were dispatched to a report of a female subject causing a disturbance on Coyote Trail. The female was deemed intoxicated and arrested for the offense. This happened on two separate occasions approximately a week apart.

## **Public Intoxication — Boggy Ford**

Officers on patrol spotted a male subject the appeared to be intoxicated walking down the roadway. As Officers made contact, the male subject started urinating in a residents lawn. The subject was cited for Public Intoxication and Disorderly Conduct.

## **Open Container in Motor Vehicle — Lohman Ford**

Officers on patrol conducted a traffic stop. Officers investigated, which resulted in the charge for having an open contained of alcohol in a motor vehicle and driving with an invalid license. The driver was cited and released for the offense.

# OTHER

## **Evading with a Motor Vehicle — Coyote Trail / Crossbow Trail**

Officers on patrol attempted to conduct a traffic stop on a vehicle on Crossbow Trail. The vehicle then fled from the officer and the officer attempted to maintain visual sight. The vehicle then drove through a field and ultimately, wrecked into a wooded area. The subject then fled on foot. Officers collected evidence from the vehicle and are pursuing a possible suspect. This case is still under investigation.
